Second shift premium is \$2.00 additional per hour. Third shift premium is \$2.25 additional per hour.

All deductions and employer contributions for overtime hours shall be at time and one-half, except for Sundays and Holidays which shall be at double time. Payment should be mailed on the appropriate form and submitted by the 15th of the month following the payroll period or a 10% penalty will be assessed.
